What does it mean to be a Title I School?



- Being a Title I school means receiving federal funding (Title I dollars) to <u>supplement</u> the school's existing programs. These dollars are used for...
 - Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the State's challenging content standards.
 - Purchasing supplemental staff/programs/materials/supplies
 - Conducting parent and family engagement meetings/trainings/activities
- Being a Title I school also means parent and family involvement and knowing their rights under ESSA.

What is the 1% set-aside and how are parents involved?



- Any LEA with a Title I Allocation exceeding \$500,000 is required by law to set aside 1% of its Title I allocation for parent and family engagement.
- Of that 1%, 10% may be reserved at the LEA for system-wide initiatives related to parent and family engagement. The remaining 90% must be allocated to all Title I schools in the LEA. Therefore, each Title I school receives its portion of the 90% to implement school-level parent and family engagement with clear expectations and objectives for meaningful involvement.
- You, as Title I parents, have the right to be involved in how this money is spent.

School Responsibilities

The Bryant Park Elementary School will:

- Staff will perform frequent progress monitoring to guide instruction.
- Staff will communicate on a regular basis with parents regarding student progress and goals.
- State-certified teachers will incorporate technology into learning.
- Integrate special activities to make learning more enjoyable Provide a stable and safe environment

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held:

- · During Meet the Teacher and Open House
- The Annual Title I Parent Meeting
- Individual scheduled conferences as needed

3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as

- Powerschool grades updated weekly by teachers
- The agenda and weekly school newsletter (PAW) will be used for communication and homework assignments

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as

- · Parents are notified of the teachers' conference times at the beginning of the year packet. All conferences are scheduled through classroom teachers
- Phone or virtual conferences can be scheduled.
- Each teacher has an e-mail address for easy communication.
- BPES has an open-door policy with the administration.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom

- Each teacher provides a sign-up sheet at the first parent meeting of the school year where parents can volunteer their services or their time in the classroom.
- · Parents have the opportunity to offer their services or expertise during a particular learning experience such as
- · Parents are encouraged to partner together through various activities provided by individual teachers/grade levels to create a positive learning environment for every student's overall success. For example, you can read to/with children, chaperone field trips, assist with parties and other special classroom events, and assist with school-wide

6. Ensure regular two-way meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand

- Agendas will be used to communicate between home and school.
 - Communication folders will be used by teachers and parents. Examples of communication may include Dojo, Remind 101, emails, texts, phone calls, and parent conferences.
- Communication will be sent to family members in a language they can understand.
- Translations will be made for parents and teachers using the TransAct platform.

Parent/Guardian Responsibilities We, as parents will support our children's learning in the following ways:

Make sure my child attends school regularly and is on time to school

- Be responsible for making sure my child understands and obeys the student code of conduct.
- Sign and return weekly folders and progress reports to monitor my child's progress.
- Sign my child's agenda or other method of classroom communication daily.
- Provide the school with the current updated phone numbers and email addresses where I can be reached.
- Attend parent meetings and conferences at school.
- Provide proper nutrition and make sure my child gets the proper amount of rest each night.
- Be responsible for making sure my child practices reading, writing, and math skills daily.

We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- - Develop and exhibit positive character traits
- Do our classwork and/or homework every day and ask for help when needed

Parents' Right-to-Know



PARENTS' RIGHT-TO-KNOW

As a parent of a student attending a Title I eligible school in the Jefferson County School System, you have the right to know the professional qualifications of the classroom teachers who instruct your child. Federal law permits you to request certain information about your child's teachers and requires the school system to give you this information in a timely manner when so requested.
