I understand that an academy is a four-year program of study except for an apprenticeship. It may include composition and literature, mathematics, science, social studies and foreign language. I also understand that I must complete the state requirements in physical education, career preparedness, fine arts, and health. Admission to an academy program for a diploma depends upon meeting admission requirements outlined for each program (see page 3). I must successfully complete the course sequence and participate in required activities.

I understand that I am expected to maintain above average conduct and an academic grade point average of 2.5 or above. If I fail to meet these expectations, I may be dismissed from the program.

To be eligible for consideration, I must meet the following requirements:

1. Have a 2.5 or above academic GPA for the last two available semesters. A copy of my permanent record card and test scores must be included with this application and I must be on track for graduation.
2. Have met special requirements for the chosen academy program; e.g. visual arts portfolio assessment, theatre audition, math/science teacher recommendation, counselor recommendation, etc. (see attached)
3. Submit a handwritten personal essay which explains why I want to attend a particular academy. Explain what I hope to gain from attending that academy as well as list any previous accomplishments and goals for the future in my chosen area of study.
4. Submit a signed student and parent/guardian contract agreeing to abide by all academy standards.
5. Show proof of my residence within Jefferson County School District.

 - c) I will complete all assignments and resubmit work that does not meet the standards;
 - d) I will be self-disciplined and meet all deadlines; and
